Objectives of the Job-shadowing mobility:

The aim of this mobility to attend a Job-Shadowing activity with the following general objectives:

- exchange professional knowledge in a multicultural context;
- enable the participant to a better understanding of English in use and to expand and build on previous knowledge;
- further develop the participant's fluency;
- experience the cultural heritage of The Netherlands.

The specific objectives of this Job-shadowing activity are to understand/search about:

- a) task based approach to learning , as well as the methods teachers and students use to assess the final products and the learning process.
- b) school self-evaluation plans.

The participation in this Job-shadowing activity will allow the participant to compare the above items in the host schools and in the sending school in order to improve teaching and education in the sending school.

Programme of the mobility period:

College to be visited the whole week: Gomarus College Groningen

Monday 13-04:

Location 1: Senior Higher Secondary Education & University Preparatory Education.

Program : conversation with the director and team leaders SHSE and UPE ; job shadowing in different classes; discussions with (special need) teachers; conversations with pupils; conversations with parents.

Tuesday 14-04:

Location: Central Service Center of the College.

Program: conversation with a board member; introduction to the Dutch education system; conversation with staff and job shadow activities.

Wednesday 15-04:

Location 2: Senior Higher Secondary Education & University Preparatory Education.

Section: Bilingual Education and Grammar School.

Program: conversation with the director and team leaders SHSE and UPE ; job shadowing in different classes; discussions with(special need) teachers; conversations with pupils; conversations with parents;
Location: Rebound Department (pupils with severe behavioural problems); conversation with team leaders on the spot.

Thursday 16-04:

Location: Preparatory vocational secondary education Drachten & Leeuwarden.

Program: conversation with the director and team leaders; job shadowing in different classes ; discussions with teachers; conversations with pupils; conversations with parents.

Friday 17-04:

Location: Practical Training Department for lower vocational education; conversation with the educational director of department ; job shadowing and conversations with (special need); feedback and certification;
Afternoon: excursion in the surrounding area, which will be offered in consultation with the guests.

N.B. In agreement participant can also stay longer at one location to immerse herself deeper in some aspects of her goals.

Competences to be acquired by the participant:

Language skills developed through continuous communication in English during the school visits, group meetings and during the activities carried out.



Monitoring and Mentoring of the participant before, during and after the mobility period:

The sending organization send one teacher to The Netherlands.

The receiving organization has to organize 5 days job-shadowing activities in one school with different locations. On request, InterPrimair can organize and book accommodation for the participants; the participants will pay the equivalent costs directly at the accommodation reception. InterPrimair will organize the (public) transport in the city/town where the schools are located.

The sending organization makes all the necessary travel arrangements and assists in the organization of all documentation needed before and after the mobility. The sending organization will assist the participants in all dissemination activities within the project.




